- Third: As a voluntary participant in any sanctioned event, acting solely on my behalf as an independent contractor, I recognize the fact that CSS does not provide Workers Compensation Insurance, Unemployment Insurance, Unemployment Disability Insurance, Federal Old-Age Survivor Insurance, or any State or Federal Taxes.
- Fourth: As a voluntary participant in any sanctioned event, I fully recognize the possibility of injury to my person and damage to my property, and I freely assume this risk as a participant in any sanctioned event.
